BYLAW NO. 6-2016

A BYLAW TO AMEND BYLAW 3-2013, A BYLAW TO REGULATE THE OPERATION & PARKING OF VEHICLES AND THE USE OF THE HIGHWAYS

The Council of the Town of Ituna in the Province of Saskatchewan enacts as follows:

1. That Section 6(c) of BYLAW NO. 3-2013 with reference to **Parking, U-turns, Public Reserve** be amended to the following:

A person who contravenes any of the provisions of the subsections of this bylaw or fails to comply therewith or with any of this bylaw or fails to comply therewith or with any notice or order given there-under shall be guilty of an offence and upon summary conviction, shall be liable to penalties as follows:

i.	Clause 4(e)(ii)	\$25.00
ii.	Clause 4(e)(iii)	\$25.00
iii.	Clause 4(e)(iv)	\$25.00
iv.	Clause 4(e)(v)	\$25.00
v.	Clause 4(e)(vi)	\$25.00
vi.	Clause 4(e)(vii)	\$25.00
vii.	Clause 4(e)(viii)	\$25.00
viii.	Clause 4(e)(ix)	\$25.00

2. That Section 6 (e) be added to BYLAW NO. 3-2013 as follows:

6. (e) Notice of Violation

i. A violator of any of the subsections of this bylaw, as set out in subsection 6(c), upon being served with a Notice of Violation, may return during the regular office hours, voluntarily pay the penalty at the municipal office within fourteen (14) days, and receive a reduced penalty of \$10.00. Upon payment, as so provided, that person shall not be liable to the prosecution of the offence.

ii. The Notice of Violation shall be in Form 2 Appendix 9, attached to and forming part of this bylaw.
