BYLAW NO. 03-2017

A BYLAW OF THE TOWN OF ITUNA TO FIX THE RATES TO BE CHARGED FOR THE USE AND CONSUMPTION OF WATER AND TO FIX THE RATES TO BE CHARGED BY WAY OF RENT OR SERVICE CHARGE FOR THE USE OF SEWER

COUNCIL of the Town of Ituna, in the Province of Saskatchewan, enacts as follows:

1. All persons desiring to be supplied with water from the Municipality's water supply system shall make application to the officials of the Municipality. Each application shall be accompanied by the payment of a meter deposit as set forth in Schedule "A" hereto attached.
2. The charges to be paid by the water consumer whose water service has been turned on shall be those set out in Schedule "B" appended hereto; provided, however, that the minimum shall be payable in every case whether or not any water is consumed.
3. Persons who own or occupy premises drained or that are by bylaw required to be drained into the sewer shall pay for such services a rental rate or service charge in accordance with Schedule "C" appended hereto.
4. Accounts for water service and/or sewer service shall cover a period of three (3) successive months, and shall be rendered on or before the first day of the month next following such period. Accounts shall be paid within a period of thirty days from the date on which such accounts are rendered. If an account is not paid within the period of thirty days, the water service may be cut off. When the water service is cut off, it shall not be turned on until all arrears have been paid, together with a fee of **Fifty (\$50.00) Dollars** to cover the expenses of turning off the water and turning it on again; provided that if it is required to turn on the water service outside the employees' regular working hours, the fee shall be **Fifty-five (\$55.00) Dollars** for reconnection.
5. The Municipality may ration or limit the amount of water furnished to any and/or all consumers should circumstances deem to warrant such action.
6. Bylaw No. 01-2015 is hereby repealed. This bylaw will go into effect July 1, 2017.
7. The rates, charges, tolls or rents contained in this bylaw shall come into force and take effect on the day of approval being issued by the Local Government Committee.

1. MONTHLY WATER RATES:

i). RESIDENTIAL

9,000 gallons or less	Minimum	\$25.00
9,001 gallons to 10,000 gallons		\$7.50 per 1000 gallons or part thereof
10,001 gallons to 12,000 gallons		\$8.00 per 1000 gallons or part thereof
12,001 gallons and up		\$8.50 per 1000 gallons or part thereof

ii). MULTI-UNIT RESIDENTIAL & COMMERCIAL

9,000 gallons or less	Minimum	\$25.00
9,001 gallons to 10,000 gallons		\$7.50 per 1000 gallons or part thereof
10,001 gallons to 12,000 gallons		\$8.00 per 1000 gallons or part thereof
12,001 gallons and up		\$8.50 per 1000 gallons or part thereof

2. MONTHLY INFRASTRUCTURE MAINTENANCE FEE:

A flat rate of \$28.333 per month or part thereof on any premises consuming water, whether metered or not, be charged to offset infrastructure maintenance costs.

SCHEDULE "C"

OF BYLAW NO. 3-2017

MONTHLY SEWER SERVICE CHARGES:

Monthly Sewer Service Charges shall be as set out below:

i). RESIDENTIAL

One-half (1/2) of the water rate as set out in Schedule "B", minimum amount of \$37.50

ii). MULTI-UNIT RESIDENTIAL & COMMERCIAL

One-half (1/2) of the water rate as set out in Schedule "B", minimum amount of \$37.50
