Bylaw No. 03-2020

A BYLAW TO REGULATE AND SET THE RATES FOR THE COLLECTION AND DISPOSAL OF RECYCLING WASTES WITHIN THE TOWN OF ITUNA

WHEREAS, pursuant to <u>The Municipalities Act</u>, a Council may by bylaw establish a schedule of charges payable by owners or occupants of land or buildings to the Town for services provided by or on behalf of the Municipality including waste management; and

NOW THEREFORE, the Council of the Town of Ituna, in the Province of Saskatchewan, in open meeting assembled, hereby enacts as follows:

INTERPRETATION AND APPLICATION

- All interpretations and applications, provisions and regulations of Recyclable Collection and Disposal Bylaw, Water and Sewer Rates Bylaw any amending or repealing bylaws, shall apply to and have the same meaning in this Bylaw.
 - "BUSINESS" means any enterprise in the Town located in any of the Commercial, Industrial, General Business Districts in the Town, including facilities such as a nursing homes, hospital, clinics and school.
 - "DWELLING UNIT" means one or more habitable rooms constituting a self-contained unit and used or intended to be used together for living and sleeping purposes by one or more persons.
 - "DWELLING ONE FAMILY" means a detached building consisting of one dwelling unit, intended to be the permanent home or residence of one family.
 - "DWELLING TWO FAMILY" means a building divided into two dwelling units, intended to be the permanent home or residence of one family in each unit. For the purposes of this Bylaw each individual "Residence" shall be rated as a "Dwelling Unit."
 - "DWELLING MULTIPLE FAMILY" means a building divided into three or more dwelling units intended to be the permanent home or residence of one family in each unit, and shall include amongst others, terrace or row houses, apartments and condominiums, a boarding or lodging house, rooming house, town house. For purposes of this Bylaw, each individual "Residence" shall be rated as a "Dwelling Unit."
 - "DWELLING SEMI DETACHED" means two dwelling units side by side as one (1) cohesive unit in terms of architectural design, appearance and construction material, with a common party wall which separates without opening, the two (2) dwelling units throughout the entire structure. For the purpose of this Bylaw, each individual
 - "Residence" shall be rated as a "Dwelling Unit."

"MUNICIPALITY" means the Town of Ituna.

Bylaw 03-2020 1 | Page ___ Mayor ___ CAO "RESIDENCE" means a building used as a home by a single family unit.

2. The following rates shall be levied to each Residence and Business for the removal and disposal of recyclable wastes, and shall be billed with the Town's current utility billing cycle, except in cases where there is one water main and utility bill, and more than one business or dwelling unit, each business and dwelling unit shall be charged and invoiced accordingly and as follows:

(a) Residential

\$20.00/utility billing/per container

(b) Business

Shall have a container for recycling and will

be billed by OSS Waste Disposal Ltd.

(d) Multiple Family

\$20.00/utility billing/dwelling unit

- 3. Subject to Section 2 of this Bylaw, the minimum charge for collection, removal and disposal of solid wastes and other refuse shall be \$20.00 per Utility Billing.
- 4. Subject to Section 2 and 3 any Business that enters into contract with OSS Waste Disposal directly for the removal of recycling waste in accordance with this Bylaw shall have their recycling fee adjusted accordingly once proof of contract with OSS Waste Disposal is confirmed.
- 5. Subject to Section 2 and 3 these rates shall apply to each resident & business with a connected utility service.
- 6. The whole or any part of the fees stated in Section 2 of this Bylaw payable for the collection, removal of recyclable wastes that remains unpaid on December 31st of the year in which the sum became payable shall be added to and thereby form part of the taxes on the land and buildings in respect of which the collection, removal, and disposal is done.
- 7. This Bylaw shall come into force and take effect on and after June 1st, 2020.
